### Life Member Article



As first Vice President of the Senior Men's Club, I was recently honored to induct Gordon Allardyce (September 30th) and A. Robert (Bob) Stevenson (October 7th) and James E. Labes as new Life Members.

An active member who has attained eighty-five years of age and has been a member for 10 consecutive years is eligible for this status. Also, a Life Member is no longer required to pay dues; however, many continue to do so. Gordon was born September 24, 1937 in Saginaw, MI, to James and Donelda Allardyce. He had two older brothers, Jim and Don.

Gordon graduated from Saginaw High School in 1955, then attended the University of Michigan where he received a Bachelor of Science in Materials Engineering in 1960. Gordon began his career at Chrysler Corporation where he attended the Chrysler Institute and received a Master of Science in Automotive Engineering in 1962.

He continued his education in night school, first at Wayne State University where he received another MS degree, this time in Metallurgical Engineering, in 1967, then at U of M for a Master of Business Administration degree in 1970.

To even further his education, Gordon continued in night school at the Detroit College of Law and received his Juris Doctor Degree in 1975.

During Gordon's 41-year career with Chrysler Corporation he held many positions in research, engineering and environmental activities. He was Director of Vehicle Certification Programs prior to his retirement in 2001.

After retirement, Gordon worked part-time for several years as an environmental engineering consultant as well as an attorney with a local law firm.

Gordon lives in Orchard Lake and served two terms on the Orchard Lake city council. He and his wife Carol have been married 57 years and are members at Kirk in the Hills where he has served on many committees. Gordon and Carol have enjoyed their travels across the United States and overseas. They spend several months each year at their second home on Lake Huron as well as their condo in Naples, Florida.

Over the years as a SMC member, Gordon has been active in the Investment Study and Reading Groups.

Bob was born October 22,1937 in Chicago, IL.

His parents moved their family to the Birmingham area in 1947. Bob graduated from Seaholm High in 1955. He graduated from Kenyon College in Gambier, OH in 1959, earning a Bachelor of Arts degree in Economics.

Soon after graduation he joined the US Air Force and became a lieutenant stationed at Fairchild Air Force base in Spokane, WA serving from 1959 to 1962.

Bobs' post graduate education garnered several degrees: a Bachelor of Laws (LLB) from University of Detroit in 1964, a Master of Law (LLM) in Labor from Wayne State and Advanced Management Program (AMP) from Harvard.

He joined Fischer, Sprague, Franklin and Ford in 1964 and was an associate. Bob then moved to Kmart Corporation and enjoyed a 30-year career as a Corporate Attorney (Labor), Assistant General Counsel and VP Public Affairs before retirement in 1995.

His post retirement "career" is just as impressive. Bob has served as an Attorney for Bloomfield Village, as an Arbitrator for the Financial Industry Regulatory Authority (stock brokers), the Center for Dispute Settlement (automotive lemon law) and Michigan Employment Relations Commission (teachers, police and fire) and Equal Employment Opportunity Commission (Discrimination). He has been a mediator for the US Postal Service and Oakland Mediation Center (District and Circuit cases).

Bob and his wife Sue were married in 1966 and reside in Birmingham and attend Holy Name Church. They spend the winter months in Naples Florida. They have 3 sons and 5 grandchildren.

Bob joined SMCB in 2005 and has been an involved member of the Special Events Committee and has chaired the annual picnic (bringing ice cream) for many years. He also enjoys the Monday Reading group discussions. Also, a 46-year member of the Birmingham Athletic Club, he enjoys tennis, squash, sailing, golf and biking. Jim was born July 30, 1932.

#### **SMC FOUNDATION NEWS**

Three years ago a small group of SMC members met to discuss the merits of establishing a SMC Foundation recognized by the IRS as a 501c3 non-profit organization as a result of the lack of accountability for our past donations to TCH. After exhaustive investigation of the requirements, composing a mission statement and the necessary bylaws, they submitted their application to the appropriate federal and state agencies. In May 2020 they received affirmation of the Foundation as a recognized non-profit organization.

For the past 65 years, the Club has successfully provided fellowship and shared interests for its members. With the creation of the Foundation, we have strengthened our commitment to community service on our terms. The Foundation serves to promote senior men activities and issues affecting the physical health concerns through charitable and educational participation.

In the past 26 months, we have received over \$72,000 from our members and friends of the Club. We have set aside and invested a quarter of these funds as an endowment and the balance is designated for future grants to worthy organizations that meet the Foundation's mission. Last year we awarded our first grant to the Oakland County Alzheimer's and this year we are pleased to announce two \$10,000 grants to the Michigan Veterans Home in Chesterfield Township and the Michigan World War II Legacy Memorial.

The Michigan Veterans Home in Chesterfield Township is the newest home opening last year and joins the other homes in Grand Rapids and Marquette. The home provides a home-like environment that celebrates camaraderie, provides peace of mind and offers extraordinary skilled-nursing care. For veterans past, present and future, they specialize in long-term and short-term care, rehab and therapy, dementia and memory care and palliative care. The grant will be used for their *Life Enrichment Programs*.

The Michigan World War II Legacy Memorial, located in Royal Oak's Memorial Park on Woodward Avenue at 13 Mile Road, is currently under construction of Phase 1. This phase includes a full-size bronze statue of a WWII soldier, over 1400 paver bricks that have been donated in honor of loved ones, and flags of the military branches. The memorial will serve as a place to gather, remember, and inspire. It is a memorial designed with the desire

to engage the community and educate future generations on the vision, values, and heroic efforts of the Greatest Generation. The grant will sponsor one of the flagpoles.

These grants were possible through donations for our members and friends of the SMC. Future grants are dependent on you. This year, we initiated our fund raising goal of \$65,000 to commemorate the Club's 65th Anniversary. So far we have received \$34,000 representing donations from only 49 of our members... less than 10% of the membership. In the spirit of Ralph Waldo Emerson's words:




So, mark your calendars now and plan to join Waller on December 12, to discover how Klara and Alfred come to grips with their love for each other in this outstanding Holiday Classic.

Our next speaker will be our Club's long time guest, and arguably one the Investment Groups best speakers, **Leon LaBrecque**. Leon's presentation will involve his 40+ years of Investing experience. Leon will share his thoughts on what has occurred in the financial markets in 2022 and what he foresee in 2023. There will be plenty of time to bring your questions and garner Leon's wisdom of various stocks and investing options.

As of the reminder writing, the Stock game that began on October 14th, is lead by John Murray who is up 46%, 2nd place is held by John Skubik who is up 42%, and Jerry Peck is in 3rd place up 39%. The top three stocks are ASML Holdings (ASML) up 57%, Lam Research (LCRX) up 46% and Caesar's Entertainment (CZR) up 42%. These percentages compare to the Dow Jones Industrial Average, which is up 14% and S&P 500, which is up 11% since 10/14/22.

The Stock game has expanded to be used as a stock research tool. Even if you are not involved in the game you can learn about stocks through the Stock Game software. The software can be downloaded for Windows users only at this time. Eventually the system will be accessible through a secure website. 
